


Mission Statement

Our mission is to provide free tax return preparation assistance and tax ${\bf r}$

education for families, individuals and seniors who qualify on the basis of income or complexity. Our tax preparation and education services help the financially vulnerable avoid predatory tax preparers, while helping them improve their knowledge and personal financial capabilities.

Our IRS Tax Law-Certified volunteers help individuals and families meet their state and



federal tax filing responsibilities at no cost. We're an all-volunteer organization. All funding goes directly to help members of our community.

VITA / TCE in Larimer County

The VITA / TCE program was created to emphasize taxpayer education programs introduced in the Tax Reform Act of 1969. VITA / TCE programs have operated in Larimer County ever since.

In the Loveland area, Volunteer Income Tax Assistance (VITA) serves taxpayers age 59 and below, with gross income up to \$73,000. Tax Counseling for the Elderly (TCE) targets taxpayers age 60 and over, with routine tax returns.

VITA / TCE volunteers also serve taxpayers with disabilities, the homebound and non-English speaking persons (where translators are available).

2023-24 Filing Season At-a-Glance

- Volunteers working Monday through Thursday at the House of Neighborly Service Life Center in Loveland provided assistance to more than 1300 taxpayers, roughly 85% of our season total.
- Selected, experienced volunteers prepared tax returns in homes and at various locations in the Loveland area, such as Good Samaritan and Mirasol senior residences. They completed more than 150 returns to accommodate taxpayers with mobility, health and other special circumstances.
- Overall, we assisted nearly 1600 taxpayers, preparing and e-filing more than 3200 federal and state tax returns.
- Total refunds exceeded \$1.5 million, including over \$500,000 in Earned Income Tax Credit (EITC), Child Tax Credit and other tax credits.
- The total estimated economic impact of refunds, credits and preparation fee savings exceeded \$3.3 million.

Tax refunds are crucial for financial security.¹

Tax time represents a unique opportunity to encourage families to build savings. The Earned Income Tax Credit (EITC) in particular can be 20% or more of annual income for low-income families. The tax refund provides a financial boost to families who are typically unable to fully cover expenses every month, helping them achieve a balanced budget over the course of the year, if only just barely. But the tax refund does more than help make ends meet.

A large majority of these dollars go to improving long-term financial security, whether through managing debt, saving for emergencies or investing in assets. Research shows that recipients spend only about 20% of their tax refund on new consumption within one month of receiving it. The rest is used to pay down debt or save for medium- or long-term needs.
